Vandemark said they need to fill out application and possible start date for construction would be 2018. He also said it was good time to apply for other grants and an engineer would need to be hired.

<u>Flags-EJR Sale of Flags</u>: Vandemark talked about the EJR flags and that we already sold two, leaving us with 23 to sell. He said we have one original and EJ's grandmother would like one. Vandemark suggested giving it to her and everyone agreed a good idea. Flyers needed for the sale of new flags and Reed will give 6 flags to Miller and Dickinson.
