- A. Computers/Server: Miller inquired how the Clerk and Treasurer were making out with one system. Tykoski said we are working with it and we may be over in hours on pay weeks. Bessenbacher Motioned to Table until November Meeting With Understanding to resolve at that time, Miller Seconded. All Ayes, No Nays, 1 Absent. Carried
- B. DDA Plan and Tax Increment Financing Plan: Vandemark explained the last page of Plan and the importance of approving the hearing, with 20 days before end of year or they would have to wait another year. Orr said they were informed by Hathaway that they could opt out. Bessenbacher said opt out was causing a lot of confusion. Council asked why Attorney was not in attendance. #### New Business:

- A. Brandy Taylor Utility Bill: Letter stating not a business and would like Utility bill corrected to a non-business status. Bessenbacher Motioned to put Utility bill back to a Single Family and Deduct Overage from Current Bill, Orr Seconded. Roll Call-All Ayes, No Nays, 1 Absent. Passed
- B. Lawyer Contacts: Reed Presented Minutes from December 10, 2012 on who can contact Lawyer and consist of the: President, Chief of Police, Treasurer, and Clerk. Council approved continuing this way to keep cost down.
- C. Signs Directing to Village Office: Granger has sign book and will get quote for both direction and office sign. Beverly Miller, audience member and DDA Member, suggested trying Flamingo Kid. Council would like 3 quotes.
- D. Public Display Board: Granger will obtain quotes or make it a Winter Project to build one.
- E. Time Clock, New Locking File, Fax Line: Granger said he could repair time clock and has new ink rolls for it. File Cabinet: Question was asked by Bessenbacher why can't a Trustee go through the locked file cabinet. Reed and Tykoski explained that the cabinet contained sensitive material and that access is restricted for that reason, we are like the Human Resource Department. Miller agreed and added that only the Clerk, Treasurer, and President should have access to it. Fax Line: Contact Charter for rates for fax line, internet, and existing phone lines. Tabled until November Meeting.

Public Comments: Kit Brunell read a prepared statement:
