<u>Financial Status</u>: Miller reported DDA starting balance of \$20649.47.Miller.Reed explained amending the budget. Miller explained 2 invoices; Royalty for \$2666.50 and M&M for \$340.50. Miller motioned to have DDA pay for half of the M&M invoice totaling \$170.25. Roll Call: All Ayes; passed. Miller motioned to have Royal invoice paid in the amount of \$2666.50. Roll Call: All Ayes; passed. Report accepted pending audit. Vandemark asked about crosswalks and Brunell replied on hold because DDA was checking other companies. Miller talked about breakfast on September 19, 2015 and DDA made \$440.00.

<u>Eric Jones Sign</u>: Grant, sports writer for Byron schools, explained doing a sign for Eric Jones and revealing it with him in the winter. Vandemark agreed with it and asked if there was a design for it. Flamingo Kid was suggested. Ayotte suggested doing something at the Masonic Lodge to earn funds. Vandemark suggested December 4 with Christmas in the Village. Gormley said you need Village approval and then hold a special meeting. Miller recommended hometown sign and Murphy seconded. Voice Vote: All Ayes; passed.

LAFF: Victor and Denny from LAFF explained about the trails committee and how it works. Having a plan is the key to where going and funding; has to meet criteria. Construction grants possible for trails and highly competitive. Informed on how to collect information and how it is key for funding. Bicyclist is big business and gave examples. Vandemark asked how to join, just Silver Lake Rd and Victor explained the dots and how to connect them, giving examples. He also explained Facebook page and quarterly meetings and a rep from DDA could attend. It was agreed that Dickinson would attend. Dickinson suggested a community meeting to see if interest is there. School has interest.

Street Painting and Way Finding Signs; Covered earlier in meeting. Way Finding Signs on hold.

Josh Russell Sign: Josh Russell explained the outreach for artist and the process in creating the signs. He also explained what could be earned. How the jungle gym, if approved, would be handicap accessible and that he would handle all permits and engineering of the project. Cost to DDA would be zero. Gormley replied yes. Vandemark asked if hearing needed and Gormley said yes. Vandemark said we need to add street scape to Master Plan. Miller said it was broad and we need to stream line it.
