Approval of Agenda: Motion to approve the agenda with; the addition of Zoning Enforcement under DPW and under new business; A) add MMTAT Training for Brandee B) add KCI Utility Billing. A) 6 Month Performance Review Mellentine and Treasurer Training: Council asked Mellentine questions and Stevens motion to raise treasurer pay to \$17.00 effective on March 19th pay: seconded by Guttersohn. Roll Call Vote: Ayes Campbell, Guttersohn, Bibbee, McDowell, Willett, and Stevens. Nays: None. Absent: Chapman. Motion Passed. Mellentine explained the training and cost. B) Sewer Rate Increase and KCI for Billing: Reed explained the recommendation made by Lynch to increase sewer rates by \$8.00. McDowell motioned to approve the \$8.00 increase for sewer; seconded by Willett. Reed explained that it takes 5-6 hours to complete the utility mailing and the time could be used for other tasks.
